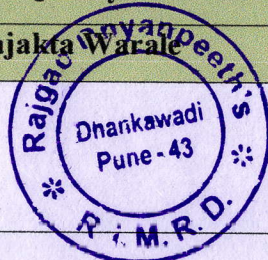

At the end the feedback form was shared to all participants . The webinar was concluded with vote of thanks.

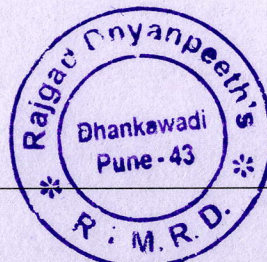
