

Mapro Food Park, Shendurjane

Objectives:

As part of the curriculum activity under the Savitribai Phule Pune University an industry visit was organized to Mapro on 21st May 2022. The objective of this visit was to make students understand how to relate theory with actual working environment. However following are the brief objectives of the visit:

- To make students understand the company ethics and culture
- To help students have practical hands on experience during interaction with company Personnel
- Industry visit help to enhance gain knowledge of food industry.

Description of Industrial Visit:

Mapro Foods Pvt. Ltd is the manufacturers and reseller s of the natural fruit products. It is one of The growing companies of India which is situated at Panchgani Mahabaleshwar Road. It produces Jams, confectionaries, squashes, jellies and many more fruit products. RIMRD, Pune organized an Industrial Visit at Mapro Food Park, Shendurjane for MBA-I year and MBA-II year students on 21st May, 2022. There are 71 students and 6 faculties visited to Mapro Food Park. The students received a very warm welcome by the company and the executives from the company guided the students at food manufacturing floor where actual production of Mapro Food taking place.

During the tour the students had practical and hands on experience about Mapro. This tour was related to basically manufacturing industry. The knowhow about manufacturing operations was also explained to the students during the tour.

The objective behind organizing industrial visit was to understand food processing industry in detail. Students visit started with visiting strawberry farm. The company provided 4 internal guides to give information about various food processing units situated at different locations in company premises. Student observed production of Jam & Jellies, crush, squashes, syrups and preserves etc. After that students visited to packaging unit. All students observed the packaging process and also clarified their doubts in interactive session.

Food and bus arrangement was made by the institute during industrial visit. Overall it was a knowledge enriching experience for all the students.

Outcomes:

The MBA Students got the live demo of the whole manufacturing process such as procurement of raw material, procession of row material, packaging process, distribution and inventory management etc.

The various process of manufacturing of food products were explained by staff of Mapro.

Students participated with enough zeal to make the visit pretty much interactive, meanwhile gaining decent knowledge about Production, Quality Control, Marketing and Operations regarding functioning of the Company.

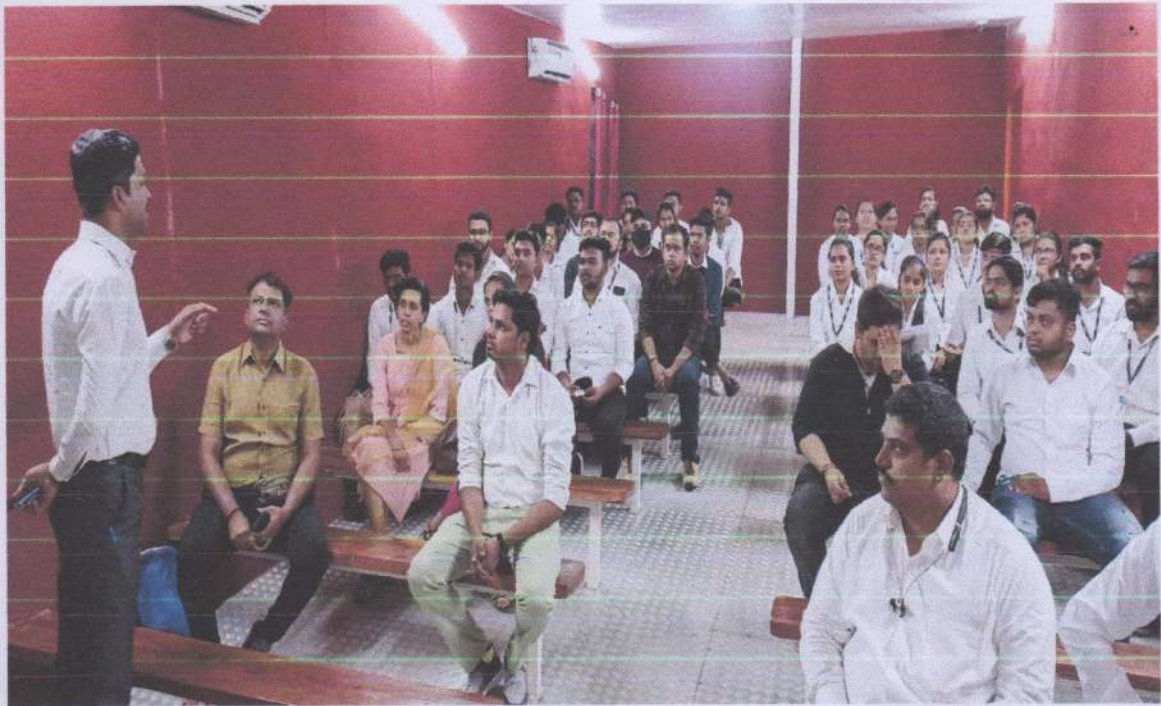
