## About the Conference

GST is 'The Goods and Service Tax' implemented by Government of India on 1st July 2017, through the implementation of 'One Hundred and First Amendment' of the Constitution of India. It was launched at midnight by the then President of India, Shri. Pranab Mukherjee and the Prime Minister of India Shri. Narendra Modi. It is an indirect tax system that relieved the various other taxes i.e. VAT, excise duty, service taxes etc. which were applicable before on goods and services. According to the Government, GST is a well structured & simplified taxation system, wherein the authoritative segregation of central government and the state government has been done. Every enterprise has dual GST model applicable, i.e. Central Goods and Services Tax (CGST) and the State Goods and Services Tax (SGST). The various percentages applicable to various sectors and businesses are 0%, 5%, 12%, 18% and 28%. The GST is applicable on various transactions such as procurement, deals, transference, barter, rent and import of goods and/or services. Considering positive impact of GST on SME's are Reduction of the tax burden on new business, Improved logistics and faster delivery of services, Elimination of distinction between goods and services, Ease of starting business, etc. and the negative impacts are Multiple registrations for Pan-India Businesses, Returns must be filed on a monthly basis, Cost of tax compliance is likely to increase, Registration will be mandatory for e-commerce suppliers and operators etc.
